**OBJECTION OF DEFENDANTS BUSH AND CHENEY TO  
PLAINTIFFS' PROPOSED EXPEDITED SCHEDULE**

On Monday evening, November 27, 2000, Plaintiffs provided their proposed expedited schedule to counsel for Defendants Bush and Cheney for review. Plaintiffs' proposed schedule ignores the fact, that after hearing full argument on scheduling issues at the hearing on Monday, this Court expressly ruled against Plaintiffs on a number of points and approved oral agreements among counsel on many others. In addition, at the hearing on Monday, the Court declined to order ballots to be transported to Tallahassee on the ground that Plaintiffs' request was premature, since it has not been established that the Complaint justifies such relief.

Because the proposed schedule ignores the Court's rulings and ignores the agreements of counsel, Defendants Bush and Cheney object. Defendants' proposed

schedule, which counsel for Defendants believe accurately reflects the rulings of the Court and the agreements of counsel is attached in calendar form as Exhibit A.

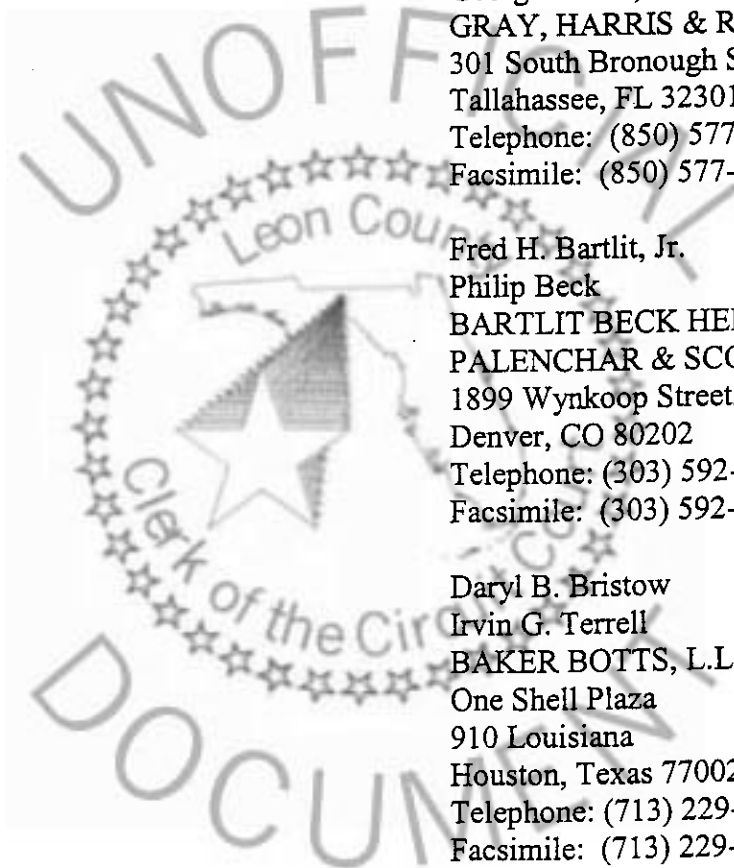


