Significant Public Interest Litigation

I have either argued or been involved in a number of major public interest cases while teaching law. A partial list of major cases includes:

Johnson v. Wetzel, 209 F. Supp. 3d 766 (W.D. Pa. 2016) (co-counsel in first reported District Court decision holding that prolonged solitary confinement constituted cruel and unusual punishment prohibited by the Eighth Amendment).

Austin v. Wilkinson, 545 U.S. 209 (2005) (argued due process challenge to placement of prisoners in prolonged solitary confinement at supermax prison before United States Supreme Court).

Ashker v. Brown (N.D. Cal. 2011) (lead counsel). Class action case challenging prolonged solitary confinement of California prisoners. Resulted in 2015 settlement in which several thousand prisoners who had spent years or decades in solitary confinement were released to the general population.

Holder v. Humanitarian Law Project, 130 S. Ct. 2705 (2010) (co-counsel in case before Court challenging sections of the material aid statute as violative of First Amendment)

ACORN v. United States, 618 F.3d 125 (2d Cir. 2010) (lead counsel in case challenging DEFUND ACORN statutes as unconstitutional Bills of Attainder).

Rumsfeld v. Padilla, 542 U.S. 426 (2004) (principal author of amicus briefs submitted by Center for Constitutional Rights and Constitutional Law Professors in Court of Appeals and Supreme Court challenging the government's power to detain American citizens as enemy combatants).

Rasul v. Bush, 124 S. Ct. 2686 (2004) (worked on petitioner's brief in case involving the jurisdiction of Federal Courts to hear challenges by prisoners detained by U.S. government at Guantanamo Bay).

Regan v. Wald, 468 U.S. 222 (1984) (challenge to U.S. government's prohibition of travel to Cuba).

Arar v. Ashcroft, 532 F.3d 157 (2d Cir. 2008), rehearing en banc granted, August 12, 2008. I am co-counsel for Maher Arar, a Canadian citizen of Syrian descent who was detained by U.S. officials at Kennedy Airport and subsequently subjected to extraordinary rendition to Syria where he was arbitrarily detained for one year and tortured. He is suing the U.S. officials responsible for his rendition to Syria.
